- To use energy resources responsibly by strictly adhering to renewable energy consumption and to increase knowledge of energy efficiency studies.
- To encourage the responsible consumption of water and energy in the organization as well as the separation of waste.
- To implement good practices in the use of consumables in offices.
- To contribute to our environmental management by continuously improving the effectiveness of the environmental management system with performance indicators and reviews in order to achieve sustainable and environmentally friendly social and economic growth.
